I agree to assume such risk for any injuries, damages, or losses that I, a participant or volunteer, and my child/children may sustain as a result of participating in any and all activities ' connected with the program.

**As a result of being injured while participating or volunteering in the program(s)**, I agree to waive and relinquish all claims I or my child/children may have against Kids Around the World and its officers, agents, servants, and employees.

**I further agree to indemnify, defend, and hold harmless Kids Around the World** and its officers, agents, servants, and employees from any and all claims resulting from injuries, damages, and losses sustained by me or my child/children or arising out of, connected with, or in any way associated with the activities of KIDS.
